WARRANTY: Crown Seating LLC warrants its products to be free from defects in parts and workmanship under normal use and service for a period of five (5) years from the date of shipment. Crown Seating LLC will not be responsible for any product failures due to abuse, misuse, modification, or improper use or for any use that exceeds the published capacity of the product. Products returned in accordance with the Crown Seating LLC return goods policy for inspection and found defective will, at the option of Crown Seating LLC, be repaired or replaced at no charge, but no claim for outside labor or charges will be allowed.

FREIGHT POLICY: All prices are F.O.B. Centennial, Colorado. Title and all risk of loss shall pass to the customer upon delivery of the products ordered to the carrier for shipment.

PRICES: Prices shall be as quoted on the price list of Crown Seating LLC established from time to time by Crown Seating LLC. All prices are subject to change without notice. The price for all sales shall be the price in effect at time of shipment. All prices are exclusive of taxes and charges for freight and insurance shall be the sole obligation of the customer.

EXPEDITED PRODUCTION: Expediting of orders is available for an additional 20% up charge. All expedited orders must be confirmed in writing. Expedited status is effective as of the date of written confirmation.

EXPEDITED FREIGHT: Expedited freight is available. Please call for current freight quotes.

PAYMENT TERMS: Payment terms are as specified by Crown Seating LLC at time of order, and if not otherwise specified, then net 30 days from the date of invoice. Crown Seating LLC (I) may suspend shipments if payment of any customer invoice is not paid when due or if Crown Seating LLC otherwise deems itself insecure and (II) shall be entitled to receive all expenses of collection (including attorneys' fees and costs) related to any action initiated, by litigation or otherwise, to collect past due amounts.

ORDER ACCEPTANCE: All orders are subject to acceptance by the home office of Crown Seating LLC and are subject to delays caused by strikes, fires, or other causes beyond our control, for which Crown Seating LLC shall have no liability whatsoever. Expedited production and delivery options available at additional cost.

FREIGHT CLAIMS: Upon receipt, merchandise should be carefully examined to ascertain that the product has been received in good condition. Any claim for damage must be made with delivering carrier within five days from receipt of goods. We do not assume any responsibility for loss or damage in transit, and compensation for such a loss must be obtained from the carrier.

REBATES, ETC.: Payment of any incentive, rebate, fee, or other bonus due a customer under any program provided by Crown Seating LLC shall be net of any unauthorized miscellaneous deduction and service charges. A customer shall forfeit any such payment if amounts owed by such customer to Crown Seating LLC or any affiliate of Crown Seating LLC are outstanding for more than 30 days on the day that the payment of the incentive, rebate, fee, or bonus is due.

DISCREPENCY: Any order discrepancy must be reported within ten days of the invoice date and any other discrepancy must be reported within 90 days of the invoice date; otherwise, Crown Seating LLC shall have no obligation to issue any credit or replace any goods with respect to the order.

CANCELLATION MODIFICATION: Orders cannot be cancelled or modified, nor can delivery schedules be changed, without the written consent of Crown Seating LLC and upon such terms that will indemnify it against any loss there from. Cancellation Fees will be issued on orders cancelled after 48 business hours.
